All vadose zone impacts were removed successfully via excavation. Six temporary monitoring wells were installed to delineate dissolved phase impacts and will be sampled for BTEX on a quarterly basis. An additional monitoring well will be installed southeast of MW5 to ensure no lateral movement of the dissolved phase groundwater plume occurred.
