Corrective Action:	<p>This location does not comply with Rule 1004 as the Operator has failed to perform final reclamation activities within the required time. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged and abandoned 02/15/2019.</p> <p>There is no indication that final reclamation activities commenced. The well location consists mostly of annual, weedy cover of Kochia and bare ground and has not been recontoured.</p>	Date 02/15/2020
	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels.
