1003 f. Weeds Noxious weeds? I

Comment SO Stored equipment, slash & debris piles have been removed; Interim areas fenced, as well as alley to allow access to dump ground, off Location. There is heavy growth of ruderal & noxious weeds (Cheat grass) in North & West Int Rec areas. Hard packed areas remain where equipment was stored. Int Rec is Not being Failed at this time; Operator is asked to conduct Veg assessment in 2020 to determine what reclamation activities are indicated for Fall 2020 (i.e: amending/re-seeding/ inter-seeding de-compacting/weed control) to assure successful re-vegetation across reclamation areas. A few were Scotch thistle plants on site, though no old growth was seen; an indication that weed control is ongoing.
