While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Unused equipment inside wellhead fencing. REMOVE TO COMPLY WITH RULE 603.F. (Corrective Action Date: June 21, 2020) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
