Form 6(s) #402077436 states well was cut and capped 7/14/2019. It was observed in this inspection that reclamation of the Location is in process; Uniform vegetative establishment observed on areas of the pad adjacent to well. Evidence of revegetation activities observed on well location and access road.

What appears to be Musk thistle rosettes were observed along areas of the access road; This is a Colorado State listed noxious weed and required management.
