While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. No signage at wellhead. INSTALL SIGN TO COMPLY WITH RULE 210.B. (Corrective Action Date: September 1, 2020) See attached photo #1.
2. Stained soil under master valve. Conduct maintenance on equipment, cleanup stained material and review self inspection processes PER RULE 1002.F(2).D. (Corrective Action Date: September 1, 2020) See attached photo #2.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
