Comment:

The Rohr 09-10 Big Pit location is not in compliance with the Final Reclamation requirements. There is an electric utility that remains along the main road at the northern area of the Big Pit. The desirable vegetation has not re-established at the northeast portion of the former pit area and equipment storage yard. There are areas of weeds, primarily Cheat grass within the areas identified. There is some debris/supplies that remains at the northeast side of the former equipment storage yard which needs to be removed. An extended corrective action date is provided to allow for reseeding to occur at an optimal time.
