During this inspection the following possible compliance issues were observed: Tank label peeling off tank and tank capacity is inaccurate. See photo #1260 with a corrective action date of 8/27/20. Multiple unused bull plugs in tank containment. See photo #1261 and #1262 with a corrective action date of 8/27/20.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
