 This Location was built on an existing land bench outside of Unocal Abandoned Mine. The bench, used as Staging and Operations area for Mine was well stabilized with large fortified concrete retaining wall. O&G Location was built, reoccupying the Mine external footprint. The foregoing; contributes to many of the Interim Rec Tabs above being NA. The existing steep slopes are well stabilized and visually are vegetated to 80% of reference slopes in area. Site remains stable and well maintained at time of this Inspection.
