While there, I observed a shut-in location. During this inspection the following possible compliance issues were observed:  
Annual weeds on location. See photo 2 through 4. Comply with Rule 603.f by 6/26/2020.  
Well is overdue for Mechanical Integrity Test. MIT requires 10-day notification via Form 42. Well plugging requires an approved Form 6 Intent to Abandon to Plug Well. Produce well after performing successful mechanical integrity test per Rule 326 or plug well. To maintain shut-in status, the well must be able to demonstrate ability to produce without mechanical intervention by 7/10/2020.  
Review of monthly operations records indicate operator is delinquent in submitting monthly operations reports. Last production reported June 2019. Well shut in at time of inspection. Submit required Form 7(s) to COGCC per rule 309 by 7/10/2020.
