Complainant thought the well was plugged but not abandoned back in November 2019. However, the well is temporarily abandoned (Form 4 Doc.# 402329855; MIT performed 11/12/2019). Refer to the attached inspection photos.

In addition, Operator has failed to respond to a previous complaint from May 2019 regarding an adjacent failed reclamation disturbance area. The disturbance area has not been properly contoured and uniform establishment of reference area perennial species has not been achieved.

Corrective Action

Comply with Rule 1003.e.(1).

Collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
