However, annual weedy vegetation (lambsquarter, Kochia and Setaria sp. (foxtail)) and some noxious weeds (Canada thistle and puncturevine) were observed. Canada thistle was observed at the early bud growth stage.</p> <p>Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator may have to perform additional reclamation activities this Fall if desirable establishment is not achieved.</p> <p>Operator has failed to re-install a portion of fence along the tank battery entrance.</p>	Date 07/10/2020
