Comment

Partially treated Canada and musk thistles observed within the project area. Approximately 150 thistles remain untreated. Approximately 200 untreated Russian knapweeds observed throughout the project area. Revegetation is progressing with dense rubber rabbitbrush, western wheatgrass, and crested wheatgrass.

Corrective Action

-Control weeds at the appropriate time and no later than 9/1/2020. Areas treated for Russian knapweed should be re-seeded with desirable perennial grasses in the fall to compete with the knapweed.
