Comment	Approximately 500 musk thistles observed within the project area. Chemical weed treatment was recently applied as many thistles are wilting. However, many of the thistles do not appear to have been treated and are in flowering condition.
Corrective Action	-Additional weed treatments/management techniques need to ba applied to control weed infestation before flowering and seed dispersal, and no later than 7/15/2020. Flowering individuals need to be bagged, removed, and properly disposed of, to prevent further weed infestation.
