TEP Rocky Mountain LLC (TEP) respectfully reports the following modifications to the production equipment on the DOE RM 2-8 Pad. TEP will install the previously proposed separators on the DOE RM 2-8 Pad except for the two (2) low pressure separators, which will be relocated to the Clough 104 pad (COGCC Loc ID: 322416). Additionally, TEP will not be installing the previously proposed tanks or the previously proposed emissions control device (ECD). The existing blowdown tank will remain in place for long-term production operations on the DOE RM 2-8 pad. Please see the attached summary document and facility layout for further equipment details.
