The equipment east - northeast of the former Andrews tank battery does not belong to Foundation, as outlined by the attached affidavit. The surface owner was in oil and gas and stages his own items there. The location was inspected in March 2020 and Foundation began the process to obtain an affidavit from Mr. Cammon, the surface owner. The efforts to get the document notarized were impeded by Covid-19 as Mr. Cammon was in California under social distancing restrictions. Foundation only returned to normal office schedules last week after lengthy disruptions from Covid, protests, etc.
