Please note corrective action has not been completed.  
Catamount Energy Partners has attached a proposed revised reclaim drawing. Catamount utilizes beam lift to operate the Lamke #1 well (05-007-06322). Workover rig operations to maintain production often require a service rig that needs to be oriented in a north south direction as depicted on the attached pad drawing. Vehicle and equipment also need to be able to move around the service rig and equipment safely. For these reasons Catamount proposes to reclaim the additional portions highlighted in white on the proposed map and not the originally proposed areas highlighted in green that would not permit workovers using a service rig. Catamount

requests permission to have this additional reclaim completed by 4-1-2020.

COGCC Representative: Operator submitted remedial report documented additional reclamation areas. Based on report, corrective action appears to be addressed.
