COGCC Environmental Inspection to determine the status of pit 109305. Based on a records review and aerial imagery, the pit was reclaimed prior to 1997. Per 1997 regulations pits closed prior to this date need only comply with surface reclamation standards. COGCC personnel found no surface indication of a pit present in the location. The pit status has been changed to closed. However, no associated remediation or site investigation has been conducted. Should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be impacted, then further investigation and/or remediation activities may be required.
