Forty-four soil samples were collected by Tasman Geosciences for analysis of TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260B. Additionally, SS04@3' was analyzed for SAR by EPA 6020/USDA60(2,3A)- Dry Weight Basis, EC by EPA Method 120.1, and pH by APHA/ASTM/EPA Methods.

## SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Tasman Geosciences will be on location to collect laboratory confirmation samples above the phreatic zone for analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene. If groundwater infiltrates into the base of the excavation, a sample will be collected for analysis of BTEX. Overburden will be sampled every 500 cubic yards to ensure compliance with COGCC Table 910-1 standards prior to utilizing it as backfill.

## REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Twelve monitoring wells were installed to delineate dissolved phase impacts. These wells will be sampled on a quarterly basis. Additional monitoring wells will be installed cross-gradient of BH19. Excavation of source impacts will occur once irrigation ceases and landowner approval is granted. Excavation is tentatively scheduled prior to November 15, 2020.
