COMMENTS:

The "DSND" was temporarily abandoned on June 25 2019, when a CIBP was set above the perforations. An MIT was successfully performed on the well on Sept 27, 2019. The wellhead is valved completely isolating the wellbore from the atmosphere. The DSND of the Simpson 8 has been TA due to low productivity and lack of gas gathering. The JSND is TA due to the low gas price and lack of a gas gathering system. Fritzler will evaluate the feasibility of converting the Simpson 8 to a gas injection well, energy storage or P&A. Fritzler Will Submit a Form 6 Notice of Intent to Plug and Abandon the Simpson 8 on or before July 31, 2020. Before October 31, 2020 Fritzler will evaluate the feasibility of converting the Simpson 8 to a gas injection or energy storage well and will submit the appropriate forms to the Commission. Also all unused equipment will be repurposed or removed as required. Production Reports have been brought current (doc 402446050)
