While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Appears to be stained soil at bradenhead. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.f.(2).d. (Corrective Action Date: August 13, 2020) See attached photo #3.
