Comment:

Records show well PA 8/25/2016; Pursuant to 1004.a, all final reclamation activities should have been completed by 8/25/2017. At least 4 growing seasons have passed.

It was observed in this inspection that Location is out of compliance with 1004 rules; Various pipe and debris appears to be stored on the Location. Gravel has not been removed; Compaction alleviation, recontouring/regrading and revegetation activities have not been conducted. No 502.b variance has been submitted by Operator, or approved by the COGCC to waive 1004 reclamation requirements.

Corrective Action:

Comply with 1004 rules; Remove debris/equipment on Location; Remove gravel; Conduct compaction alleviation (cross-ripping to a minimum depth of 18 inches); Recontour/Regrade Location; Conduct revegetation activities- Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
