Comment: The access road and the location bare of vegetation and soils seem to be compacted. The soils are not stabilized and are susceptible to erosion. Additional reclamation is needed in order to establish 80% vegetation cover. The disturbance area of the location is approximately 3.5 acres and most of the location does not have vegetation. Previous corrective action date remains to document non-compliance.
