Backfill the pit pushing in the south berm first, then east and west berms to ensure all inorganic impacted soil that is above standards 910 - 1 is buried 3 feet below surface. Any gravel left from the tank battery will be then buried in the pit. The north berm will then be backfilled and finally clean topsoil will be brought in to bring pit grade up to match surrounding area. Surface samples will be taken to ensure inorganics are under standards at the surface. The entire tank battery and pit will then be final graded and cross ripped. The project is in crop land, so no seeding will be needed and the land will be turned back over to the farmer for crop use.
