## COMMENTS:

The 2020 annual bradenhead test dated 7/7/2020, had an initial pressure over 50psi. Based on the 2019 annual bradenhead test results, Extraction implemented a bradenhead blowdown mitigation strategy outlined in Form 4 DOC#: 402237383. The attached chart shows the results of this mitigation strategy. The blowdown mitigation was unable to maintain bradenhead pressures below the 50psi threshold outlined in Operator Guidance Order 1-232. The following information was gathered during the blowdown: Flowrate of 25.5MSCF/D Volume of 0.175MSCF. To comply with the operator guidance Extraction intends to route the bradenhead gas to a combustor at the facility via the existing flowline.

The Young 4-31 bradenhead gas sample indicates a mixture of thermogenic and microbial gas. When compared to the production gas sample taken, the bradenhead gas sample is less thermally mature indicating it is sourced from a shallower formation in the well, when compared to the production gas sample taken from the J-Sand-Niobrara-Codell Completed intervals.

Operator shall implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare.</li><li>2. Prior to starting bradenhead abatement, if a sample has not been collected within the last twelve months collect bradenhead and production gas samples for laboratory analysis. Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results shall be provided to the COGCC within three months of collecting the samples.</li><li>3. Bradenhead gas is not to be vented to atmosphere; any gas from the Bradenhead will be routed to an enclosed tank and/or combustor. Operator shall implement measures to get an initial estimate of the gas flow rate and/or volume from the bradenhead. The abatement program may be used for six consecutive months.</li><li>4. Operator will submit a Form 42 ("OTHER") stating that "bradenhead abatement program has started."</li><li>5. At the conclusion of the six months, conduct a new bradenhead test and submit the Form 17 within ten days of the test and submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans and the flow rate information and pressure data.</li></ol>
