On 8/5/2020 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Stormwater controls need to be installed to stabilize erosion within the project area, by 9/10/2020.

Note that shotgun shells, a sign next to fired equipment used as target, observed within the project area. Use of firearms on the well pad likely poses a safety risk. Measures should be taken to prevent firearm use on the well pad.
