INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On August 25, 2014, historical impacts were discovered during abandonment activities at the UPRC 15-6K, 15-3K production facility, and excavation activities were initiated. Groundwater was encountered in the excavation area at approximately 2 feet below ground surface (bgs). The COGCC issued Spill/Release Point ID 438733 for this release.

Soil samples were collected as described in the Initial Form 27 (COGCC Document No. 200438750). Based on the data presented, impacted soils in the excavation area were remediated to be in full compliance with the COGCC Table 910-1 standards.

Proposed Groundwater Sampling

☒ Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Between June 9, 2015 and June 5, 2019, ten (10) temporary groundwater monitoring wells (BH01 - BH10) were installed to further assess the extent of groundwater impacts and for remediation purposes. Quarterly groundwater monitoring was initiated on June 15, 2015, and is ongoing at the nine (9) temporary monitoring wells remaining at the site (BH02 - BH10). Monitoring well BH01 was noted as destroyed on July 26, 2018, and was subsequently replaced with remediation well RW01. Groundwater samples are collected from the temporary monitoring wells on a quarterly basis and analyzed for benzene, toluene, ethylbenzene, and total xylenes (BTEX). Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 1. The laboratory analytical reports for the previous four quarters of groundwater monitoring are provided as Attachment A.

Hydrocarbon-impacted groundwater remains at the site. SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

On August 25, 2014, approximately 100 cubic yards of impacted material were excavated and transported to the Buffalo Ridge Landfill in Keenesburg, Colorado for disposal. Approximately 320 barrels of impacted groundwater were removed from the excavation area via vacuum truck and transported to a licensed disposal facility.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory data indicate that impacted soils in the excavation area have been remediated to be in full compliance with the COGCC Table 910-1 standards. Prior to backfilling, approximately 200 pounds of OxPure® activated carbon were added to the groundwater within the excavation area to mitigate remaining hydrocarbon impacts to groundwater. The SDS for the activated carbon used at this location is provided as Attachment B. Air sparge / enhanced fluid recovery (AS/EFR) has been selected as a remedial technology to address remaining dissolved-phase groundwater impacts at the site. Bi-weekly mobile AS/EFR events were initiated on July 11, 2018, and are on-going. AS/EFR operational details were provided in the approved USEPA Underground Injection Control (UIC) permit application, included in the Form 27-Supplemental Update (COGCC Document No. 401671102). To-date, a total of approximately 34 barrels of groundwater have been removed during AS/EFR activities at the site. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in full compliance with the COGCC Table 910-1 standards for four consecutive post-remediation quarters. Estimated time to attain NFA is TBD based on the groundwater concentrations, the extent of impacted groundwater, and the efficacy of the selected remedial technologies.

The temporary monitoring wells (BH02 - BH10) will be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with the COGCC Table 910-1 standards for four consecutive post-remediation quarters. Groundwater sample locations are illustrated on Figure 1, and a potentiometric surface contour map for the Third Quarter 2020 is presented as Figure 2. Well completion logs for the temporary monitoring and remediation wells are included as Attachment C.
