#### COMMENTS:

On 5/19/2020, Noble performed a blow down on the Coleman C23-19 well. The starting pressure was 19 psi, and collected 4.5 mcf of gas and 0 gallons of liquid. On 8/9/2020, a Form 17 was completed with a beginning pressure of 8 psi and ending pressure 0. A bradenhead and production gas sample was collected on 3/24/2020 and submitted via a Form 43 on 5/22/2020. After one blow down, we have seen improvement in this well and would like to request this well be released from the Abatement program. This well is in compliance with Order 1-232 and will be returned to annual testing.
