**General Comment:**

On 8/31/2020, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at SG Interests' Volk 12-89-21 #1 location in Gunnison County, Colorado.

This inspection is a followup to inspection #696201320, to document compliance with the following corrective actions:  
1002.f.(2)C: Install or repair required BMPs in accordance with good engineering practices by 6/11/2020.

It was observed in this inspection that the Location remains out of compliance with 1002.f.(2)C

Comment: Inspection #696201320 observed that stormwater and erosion control BMPs on the Location were insufficient, or missing pursuant to 1002.f.(2)C. Operator was required to comply with 1002.f.(2)C by 6/11/2020.

It was observed in this inspection that Location remains out of compliance with 1002.f stormwater rules. BMPs remain missing or insufficient to protect and stabilize the cut and fill slopes of the Location; Erosion degradation evident. Stormwater ditch BMPs on the perimeter of the pad, and the western areas of the Location have not been constructed in accordance with good engineering practices, including a sufficient outlet to allow for sediment laden-free stormwater discharge.

Original CA has not been addressed and remains applica ble.

Corrective Action: Install or repair required BMPs in accordance with good engineering practices per Rule 1002.f.(2)C. Conduct revegetation/reseeding activities on the slopes and install erosion controls to stabilize the seeded soil.
