Comment

FIR #696201526 documented that noxious weeds (Bull thistle, *Cirsium vulgare*) have established in the northern interim areas of the Location. Inspection required Operator comply with Rule 1003.f.

It was observed in this inspection that weed management has not been conducted, or was insufficient and not "ongoing" per the corrective actions; Noxious weeds observed on the interim areas of the Location (Bull thistle, Musk thistle) have been allowed to reach maturity; seed dispersal via wind was occurring at time of inspection; seeds observed being transported off-location.

Operator failed to conduct sufficient ongoing weed monitoring and management to prevent the establishment and spread of noxious weeds, pursuant to Rule 1003.f.
