COMMENTS:

The 2020 annual bradenhead test was conducted on this well on 08/07/2020, Form 17 doc# 402468322, showing surface casing pressure of 176 psi, which is above the 50 psi threshold. Bonanza Creek is requesting to conduct a 30-day blowdown followed by a 7-day build up as a mitigation plan for this well.

This well will be put on mitigation as soon as this NOI is approved. A gas/fluid sample is planned to be collected prior to mitigation of this well (if present), anlaysis submitted via Form 43. Pressures during mitigation will be recorded and a chart will be provided in the post-mitigation subsequent report sundry notice.
