Comment: **Records show well PA 5/9/2017, at least four growing seasons have passed. It was observed in this inspection that this Location is not progressing towards COGCC 1004 standards; Large areas on the south end of the Location, and access road remains bare soil, or predominantly undesirable weedy plant species and not reflective of the reference area; Reference area perennial forage cropland. Noxious weeds such as Chicory, and Tamarisk were also observed on the Location.**

Corrective Action:	Comply with 1004 rules and conduct additional reclamation and weed management; Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	Date	10/31/2020
