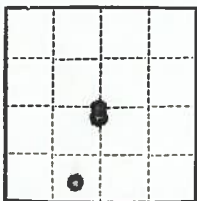

DETAILS OF WORK

Gulf Designation: Ballinger-Federal No. 2a

After unsuccessful attempt to fish 2 loose joints of 8-5/8" OD surface casing the hole was plugged and abandoned and rig skidded 12' west. The new hole will be drilled to an estimated TD of 6100' to test the Entrada. Approximately 350' of 8-5/8" OD surface casing will be set and cemented to the surface. If commercial production is encountered, 5-1/2" oil string will be set. All potentially productive formations will be adequately evaluated either by coring, drill stem testing or electric logs.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
