It appears that vehicle traffic is accessing site; leaving portion of site as well as road compacted and bare of vegetation except for Russian thistle established on road edges. Across the site, vegetation though well established in portions, is not yet uniform and sparse in areas. Stormwater concerns have developed in South end or drainage area of site. Noxious weeds, Hounds tongue &amp; Canada thistle are growing on edges of location and in drainage area.</p>
