The two drilling pits have been backfilled however, soils have not been recontoured and reclaimed. The diversion ditches have not been backfilled and reclaimed. There are erosion issues along the ditches. There is pit liner debris that remains around the location. There are undesirable weeds throughout the location and areas of bare soil which are susceptible to erosion. Undesirable weeds will need to be removed and controlled. Soils will need to be recontoured and decompacted by cross ripping to a depth of 18 inches. The site must be reclaimed back to cropland or a perennial vegetation cover. Corrective action of the previous inspection has not been completed.
