On 4/1/20, a CIBP was set @ 9090' over the Lyons with 4 sx of cement for a MIT. The plug was left downhole after the test. This well is closed to atmosphere by 5K wellhead. This well will be evaluated for leasehold or P&A'ed as budget allows after 2020. The MIT was reported via form 21.
