Comment:

The access road and location have not been reclaimed. There is equipment that remains on the location. All equipment should have been removed within 3 months of abandoning the well. There is undesirable weeds (Kochia) throughout the entire location which have grown 4-6 feet tall. The weeds are a fire hazard and will need to be cut and removed. The location will need to be reclaimed to reestablish a uniform crop cover. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
