	<p style="color: blue;">Location does not meet Final Reclamation requirements. Access road has not been Reclaimed. Site vegetation is composed mainly of Noxious & ruderal debris weeds; Scotch, Bull and heavy establishment of Russian thistle. Desirable vegetation is not emergent under weed cover. As site was PA'd in 2014 revegetation should be meeting or close to the 80% requirement. Weed control efforts were visible, though conditions warrant assessment of site and further work to establish uniform desirable vegetation.</p>	
Corrective Action:	<p style="color: red;">Assess vegetation, soil and site conditions; re-seeding, applying remedies as indicated by assessment, to ensure the uniform establishment across the site of desirable vegetation. Conduct noxious weed management and monitoring to prevent further weed establishment. Management efforts will need to be ongoing until final reclamation has passed. Reclamation Activities to be complete by November 15, 2020.</p>	Date _____
