Perform Final Reclamation per COGCC 1004 Rules including re-contouring, seeding of site and stabilizing slopes of any remaining portions of road. Install appropriate BMPs to stabilize location until vegetation establishes, controlling Noxious weeds. All Reclamation Activities to be complete by November 16, 2020.
