No well APDs were submitted with the 2A, or appear to have been permitted on this Location. 2A Permit #400032194 expired 04/08/2013; Location subject to 1004 final reclamation requirements.

The designated main access road traveling through Location, southeast to the Battlement Mesa 34-24 pad (Loc. #324299) remains active, in use and will not be subject to reclamation requirements at this time. However, the second access road that travels east from the Location to the Battlement Mesa 26N-795 pad (Loc. #334128) does not comport with Rule 1002.e(4), and will also be subject to reclamation requirements.

Corrective Action: **Comply with 1004 rules and conduct final reclamation on the Location, and eastern access road.**
