Comment It was observed in this inspection that there are three (3) Oil and Gas access roads leading to/from the Location; Doc. #400945215 identifies the road that travels south from the Location as the designated access road. The access road leading west to the PAD 27I-BATTLEMENT MESA /26-14B (Loc. #416540), and the access road that travels southeast from the north end of the location are considered additional, unnecessary disturbances that do not comport with Rule 1002.e(4), and require reclamation.
