General Comment:

On 9/24/2020 COGCC Staff, Kris Neidel inspected Conoco Fed 34, Well #1 and the adjacent area that is a part of Remediation #15777. Weather was and 60 degrees and smoky from nearby forest fires. The well was PR at the time of inspection (well pumping). Gas was venting out of a needle valve on wellhead (see Required Action below). Weeds were present at wellhead. On 4/8/2020, COGCC staff observed oil impacted soil. Remediation Project 15777 was created to document the remediation of observed impacts. On 9/24/2020 COGCC staff observed the impacted area, no hydrocarbon impacts were observed (staining or odors). Required Action: If prior approval to vent gas has not been granted (via Sundry, Form 4), immediately cease venting. Per COGCC Corrective Action Matrix. By 10/15/20 remove weeds at wellhead.
