## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Two (2) partially-buried produced water vessels (PWV) were removed from the Green 1N, 1C, 2N, 3N, 4N-8HZ facility on September 22, 2020. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was present beneath the PWVs at this site. The PWVs at this facility have been replaced. Soil samples from the excavation were submitted for laboratory analysis to determine if a release occurred. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample locations are illustrated on Figure 2.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On September 22, 2020, eight (8) confirmation soil samples were collected from the sidewalls and base of the final extents of the excavation area at depths of approximately 4 and 5 feet below ground surface (bgs), respectively. The base soil samples were submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO) and oil range organics (ORO) by USEPA Method 8015D, pH by USEPA Method 9045D, specific conductance (EC) by USEPA Method 9050A, and sodium adsorption ratio (SAR) by USDA Agricultural Handbook 60 Method 20B. The sidewall soil samples were submitted for laboratory analysis of BTEX, naphthalene, and TPH.

Laboratory analytical results indicated that constituent concentrations in the soil samples collected from the final extents of the excavation area were in full compliance with COGCC standards. The base soil samples were collected above the liner. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample locations are illustrated on Figure 2. Soil analytical results are summarized in Table 1. The laboratory analytical report is provided as Attachment A. Two partially-buried PWVs were replaced with an above ground steel tank during facility upgrade activities.

Laboratory results indicate that constituent concentrations in the soil samples collected from the final extents of the excavation area were in full compliance with COGCC Table 910-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

## REMEDIATION SUMMARY

Laboratory results indicate that constituent concentrations in the 8 soil samples collected from the final extents of the excavation area were in full compliance with COGCC standards. Groundwater was not encountered in the excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
