Comment: Final Reclamation has been installed as required by previous RI Insp. Road and location have not successfully revegetated. Russian thistle and Halogeton are predominate, with few emerged grasses heavily grazed and site has endured considerable animal impact. Operator has indicated ongoing difficulties with excluding livestock from Location.

Corrective Action:	Assess vegetation and site conditions; controlling weeds, re-seeding, applying remedies as indicated by assessment, to ensure the uniform establishment across the site of desirable vegetation. Reclamation Activities to be complete by November 30, 2020.	Date	11/30/2020
