The access point move was at the request of the surface owner and is close to the proposed WHP Misty Production Facility. KODA planned the haul route to the WHP Misty 2-7 well location from the north; however, the Lincoln County Road and Bridge Division requested KODA change the haul route to come from the south since there is a bridge with weight restrictions near the intersection of C.R. 32 and C.R. J north of the location. A revised Access Road Map is attached.
