Comments:

The well pad and southern extent of the associated access road have been reclaimed and returned to cropland. Access road entrances of the facility and well pad have been reclaimed and match adjacent roadsides. The northern extent of the well pad access road and the facility disturbance area are within the corner of the rotary irrigated field and have been returned to the landowner and left fallow for a minimum of 4 consecutive years. A COGCC Reclamation Inspection (Doc # 682402454) in 2017 documented successful reclamation of the well pad and the fallow state of the facility. In 2018, a home was built in the corner of the field in which the facility was located. On-site reclamation assessments conducted by PDC contractors in 2019 and 2020 confirmed the findings of the 2017 COGCC inspection and documented the continued fallow state of the facility disturbance. Subsequent land owner communication by PDC in September of 2020 established that the current land owner has taken possession of the disturbance area, has no definite plans to cultivate the corner of the field as crops, has been harrowing the area to mitigate weeds, and may seed dryland grasses in the future. Based on the field assessments and correspondence, the facility disturbance has been reclaimed and returned to the landowner with a designated final land use as residential property, matching adjacent reference areas. Weeds are being controlled and the site poses minimal risk for erosion. Please see the attached report for additional reclamation activities, details on the completed vegetation assessment, and photo documentation.
