The sundry approved 8/28/2020 for a blowdown mitigation strategy (DOC#: 402476521) stated an approximate start date of 7/1/20 with six months of consecutive blowdowns approved. Extraction has not been able to conduct blowdowns due to the nature of the bradenhead pressure. Extraction would like to close out the blowdown bradenhead mitigation strategy. To comply with the operator guidance Extraction intends to submit a Form 6 NOIA and plug the well.
