This location was treated for weeds on 6/18/20. SG has invoices to prove and will submit to COGCC upon request. Please note SG does not understand the term "debris" used in the field inspection report. Please also note the grass in the diversion ditch is not being considered a weed by SG - this is a brome species and was intentionally planted to aid in stabilizing the stormwater ditch. In addition, the inspection note stating "production facilities, shall be kept free of weeds and debris" needs to be clarified. Several inspectors are inconsistent with this requirement and SG is unsure how to comply with it. However, as stated, SG sprayed weeds on the location

on 6/18/20 per our Weed Mgt. Plan. Please also note the inspector has identified this as a second corrective action for weeds, but SG provided a FIRR stating the weeds were treated.
