Inspection #696201613 and 696201797 documented that the secondary containment BMP at the 200 bbl Condensate AST was insufficient, and required Operator to comply with Rule 906.d.(1).

It was observed in this inspection that the condensate tank has been removed from the Location. Corrective action is no longer applicable.

Area of the tank is considered "not needed for production", and is subject to 1003 interim reclamation requirements.
