A limited excavation of source removal occurred on August 8, 2020 where 40 cubic yards of impacted material was removed. A subsequent excavation was conducted on November 2nd and 3rd, 2020 where 30 cubic yards of impacted material was removed. Confirmation laboratory samples were collected by Eagle Environmental for analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene.
